THE DEPARTMENT

In the heart of the City's operational excellence lies a visionary alliance between fiscal responsibility and strategic vision, orchestrated by the Budget Department. This intentional fusion ensures that the budgetary processes remain attuned to the overarching vision, fostering year-round dedication to alignment and engagement throughout the organization.

At the helm of this critical endeavor is the Director of Budget, a key steward reporting to the City Manager through an Assistant City Manager. Charged with upholding the City's financial integrity and fortitude, the Director orchestrates the convergence of resources with the City's intentional planning efforts.

Within this dynamic framework, the Director oversees a multifaceted operation of six (6) FTEs and a departmental budget of \$1.12M, encompassing both budgetary oversight and strategic financial planning for the entire organization. Guiding a unified team, the Director fosters a culture of mentorship, innovation, and shared responsibility, empowering department directors to realize their visions while advancing the City's collective goals.

The City recognizes that true progress emerges from the seamless integration of vision and action. Thus, the Director of Budget will be supported and empowered to impact the City's future through fiscal stewardship and strategic foresight, propelling the city to new heights of prosperity and resilience.

THE POSITION

The Director of Budget is charged with advocating for the advancement of the City's commitment to conservative financial stewardship, the integrity and well-being of the City's budget, and the alignment of resources with intentional city-wide strategic planning efforts.

Through stewardship of the Budget Department, the Director is responsible for providing the organization with the development and leadership of the annual budget and five-year CIP, long-range financial forecasts and planning, and organizational performance measurement efforts.

The Director will be well-versed in and avid about collaboration, as all efforts will require working closely with departments across the City – most notably working with the Engineering Department, which provides expertise and regulatory guidance for all planning, design, and construction of the CIP, as well as the Department of Data & Innovation, which provides the expertise on data creation and analytics, and the Department of Strategic & Government Affairs, which provides the expertise on aligning the organization's actions with the long-term vision for the city.

The Director of Budget will lead a unified team by reinforcing a culture of mentoring, problem-solving, innovation, and sharing responsibility for budget and business strategy leadership across the organization. This includes assisting department directors in achieving their departmental visions and working alongside the Department of Strategic & Government Affairs to achieve the City's vision through strategic budgeting, purposeful planning, and performance management through outcome-based budgeting.

Additional duties and responsibilities of the Director of Budget include, but are not limited to:

- Lead the compilation of the annual budget, inclusive of all funds, forecasts, and five-year CIP in accordance with the City's FMPS and strategic plan.
- Assist the Department of Strategic & Government Affairs and city management, departments, and the City Council with the development of long-term goals, objectives, strategies, and actions, including the development of the annual strategic work plan to ensure it is in alignment with the City's vision, mission, goals, and budget.
- Advocate for budgetary and strategic decisions that support the maintenance of the City's AAA bond rating and the ability to offer residents and businesses with one of the lowest tax rates in the state of Texas among cities its size.
- Lead the City's participation in the Government Finance Officers Association (GFOA) Distinguished Budget Program – ensuring the City's budget meets the highest principles of government budgeting and the GFOA's criteria as an effective policy document, a financial plan, an operations guide, and a communication device.

- Advocate for the performance management program and assist department directors, the Executive Team, and the City Council with the development of goal measures and performance measures.
- Mentor and develop staff to ensure they work effectively on elements of the annual budget and CIP, as they pertain to the assigned departments, so those departments recognize the Budget Department staff as valuable sources of advice and assistance on critical policy issues affecting the organization and their departments.
- Participate in the city-wide continuous improvement, process improvement, and performance management efforts – both as Director of the Budget Department, but also as a citywide advocate for all things budget and strategy.
- Establish and maintain a working environment conducive to positive morale, innovation, quality, creativity, and teamwork. Provide development opportunities, mentoring, and succession planning to attract and retain qualified employees.
 - Contribute to team efforts by performing other duties and responsibilities as assigned by the Assistant City Manager, an Executive Team member, the City Manager, or their designee.
